FINANCIAL ASSISTANCE INFORMATION

2017-2018 School Year

The Board of Directors of St. Stephen's Episcopal School has adopted a fee schedule for the 2017-2018 school year. When financially possible, tuition payments may be made on a semester basis in two installments. The first payment is due August 1 and the second payment is due January 1. Annual tuition payments also may be made. Payments made on a monthly basis will begin June, July or August, according to the payment plan you indicated on the enrollment application.

Please note that the 12-month plan can ONLY begin in June and the 10-month plan can ONLY begin in July and August.

For students who begin after the start of school, total tuition will be divided equally over the months remaining through May.

No payment plans may extend past May.

Families who wish to apply for Financial Assistance must submit an application form to the Head of School, accompanied by the family's 2016 federal tax return. All information will be kept strictly confidential and will be available only to the Scholarship Committee of the Board of Directors.

Financial assistance is available for students entering Kindergarten through 8th Grade.

No assistance is available for student enrolling in the Preschool or Pre-kindergarten classes.

DEADLINE FOR APPLICATIONS: **APRIL 21, 2017** for 1st round awards. Limited financial assistance might be available throughout the summer.

Applications for Financial Assistance will not be processed until a completed registration form and appropriate fee is received.
